wie bereits besprochen, arbeiten wir im Hintergrund an der Entwicklung unseres eigenen Vertriebs für BlockRock & GainSpot. Wie angekündigt, erfordert diese Entwicklung eine Erhöhung der Transaktionsgebühren auf 8% beim Kauf und 10% beim Verkauf. Darüber hinaus werden automatisch 10% aller Einnahmen, beispielsweise durch LPs oder verkaufte Assets, in das Vertriebsund Team-Wallet übertragen.
